

OPTION # 1
DEFENSIVE DRIVING SCHOOL
ADVANTAGES:

1. You will not have to pay a fine for that **ONE** traffic violation.
2. You will not have to go to court for that violation. That violation will be dismissed.
3. No points will be assessed against your driver's license for that violation. Points on your driving record may cause an increase in insurance rates.

You Are Eligible IF:

1. You have not attended a Defensive Driving Course for ticket dismissal in the past 24 months, violation date to violation date.
2. The violation code written on your citation is listed on this slip, with an asterisk (*).
3. Your violation code was not issued from an accident involving death or a serious physical injury.

THIS COURSE MUST BE COMPLETED

BEFORE THE COURT DATE. If you do not complete the course prior to the court date, you must appear in court or you will be subject to the fine, a time payment fee, a default fee, a court technology fee and collections.

HEARING TO BE SCHEDULED

1. **READ & SIGN** the following statement:

"I request a hearing to contest the charges indicated below. I enter my plea of not responsible. I understand I am giving up my option of attending Defensive Driving School. I understand that I may voluntarily enclose a bond (cashier's check or money order) equal to the fines plus the court technology fee, which will be forfeited should I fail to appear for my hearing. I further understand that the bond forfeiture will relieve me of the possibility of the court assessing additional monetary sanctions, including a suspension of my driver's license, should I fail to appear for the hearing."

INFORMATION

A.R.S. 28-907A - CHILD PASSENGER RESTRAINT
 Mail receipt proving purchase of child passenger restraint system after date and time complaint was issued and fine may be reduced to \$0.

A.R.S. 28-2532A - NO PROOF OF CURRENT REGISTRATION
 Mail proof of current AZ registration and fine will be reduced to \$125.00. Send cashier check/money order at the same time to the court. Payment must be received by your court date.

A.R.S. 28-3169A - NO DRIVER LICENSE IN POSSESSION
 Will be dismissed with proof of valid driver license on date and time complaint was issued.

A.R.S. 28-3473 - Driving on a Suspended License
 If you are charged with a violation of 28-3473A or 28-3473C, you should contact the Motor Vehicle Department. Proof of reinstatement of your license can significantly reduce your sentence.

A.R.S. 28-4135B and 4135C- NO PROOF OF INSURANCE
 carries a fine ranging from \$940.00 to \$1860.00. If you mail proof showing that the vehicle involved was insured ON THE DATE AND TIME COMPLAINT WAS ISSUED and the proof is received by your court date, the charge will be dismissed. If there was no insurance in effect at the time of driving, you must appear in court. At that time you may have your fine reduced if you present proof of 6 months current insurance.

NOTICE

You **MUST** respond to this citation on or before your arraignment date.

You must appear in court unless you choose one of the options explained on the back of this page. For directions to the court call **623-815-2186 or TDD (623) 933-3258**.

You must appear in court if your citation was issued as a result of an accident involving death or a serious physical injury.

Failure to appear for a criminal violation on or before your arraignment date will result in a warrant being issued for your arrest.

Failure to appear for a civil violation on or before your arraignment date will result in the suspension of your driver's license. In addition there will be a \$40.00 Default fee added to each charge, a \$20.00 Time Payment fee and a \$46.00 Court Technology fee. Your case will also be added to the Fines/Fee and Restitution Enforcement Program (FARE), where there will be additional fees and your credit may be affected. If you would like further information on the FARE program, you may contact the court.

You may use the Defensive Driving Program for only one eligible violation code. If you received more than one violation code on your citation, the other violations must be resolved using options 2 or 3 or by appearing in court.

IMPORTANT NOTICE: If you have been cited and are found responsible for 28-645A3A, or are under age 18 (First Offense) and are found responsible for moving violation, you will be required to attend a traffic survival school (TSS) class by the motor vehicle division (MVD) pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for the defensive driving program and complete the class, the violation will be dismissed and you will not be subject to the requirement to attend a TSS class by MVD.
